Martin informed Council that Park Board is ready to purchase the playground for Archbold Wilson Park. A 50% down payment of \$26,610 is needed to start the order. Brickley motioned to approve payment of \$26,610 for the playground using the funds raised for the park, Kemper seconded. Passed 4-0

Martin informed Council that she has a final meeting tomorrow at 103 N Jefferson and hopes to obtain a quote for demolition soon after. Brickley stated that she thought fencing/ barricading out in front of the building would be a good idea in the meantime. NAPA business owner asked a few questions including the drainage in the 103 N. Jefferson building. Barkley said he doesn't believe there's currently any tile.

Brickley motioned to approve Allowance Authorization #1 for WWTP Improvements 2020 Project decreasing the allowance \$1,365 of the original contingency \$75,000, Pursley seconded. Passed 4-0

Pursley Motioned to approve payment application #3 of \$141,117.29 to Cornerstone for WWTP Improvement Project, Brickley seconded. Passed 4-0

Brickley Motioned to approve payment application #1 of \$212,553.59 to API Construction, Pursley seconded. Passed 4-0. No action was taken for payment application for retainage since there was a question on the amount listed.

Mike Lautzenheiser, from Area Plan Commission, sought approval of modification requests for FHG Development's Petition for Major Subdivision for Crosswind Lakes. Brickley motioned to adopt waivers as presented, Pursley seconded. Passed 4-0

Brickley motioned to accept the resignation of Rose Barrick from the Ossian Stormwater Management Board, Sewer Committee, and Wells County Board of Zoning Appeals, Pursley seconded. Passed 4-0

Brickley motioned to approve License for Improvements for 404 Willowood Dr and 422 Greenwood Trail, Kemper seconded. Passed 4-0

Brickley asked if the Code Enforcer job had been posted yet. Martin said no and that she wants to change the job description to put more responsibility with the job.

Allison presented the following for 2021 budget timeline and Council agreed: August 10th discuss budget, September 14th Public Hearing, October 12th Budget Adoption.
