Council President, Josh Barkley called the meeting of the Ossian Town Council to order with Council members, Brad Pursley, Jason House, Jeff Kemper and Renee Sweeney present.

Barkley opened the Public Hearing for the fees and charges for use of the Archbold Wilson Event Center. There being no comment or questions from the public, Pursley motioned to close the public hearing, Kemper seconded. Passed 5-0

Barkley opened the Public Hearing for the rates and charges for criminal history checks, fingerprints, and police reports. There being no comment or questions from the public, Pursley motioned to close the public hearing, Kemper seconded. Passed 5-0

Barkley opened the Public Hearing for additional appropriations for the 2021 budget. There being no comment or questions from the public, Pursley motioned to close the public hearing, Kemper seconded. Passed 5-0

Pursley moved to approve the minutes of the February meeting. Kemper seconded. Passed 5-0

Chief Rigney discussed the Police 2020 annual report with Council. The Durango is supposed to arrive tomorrow. Rigney asked if Council would like him to obtain bids for equipping the vehicle. Barkley motioned to allow \$9,000 to equip the new Durando, Renee seconded. Passed 5-0. Police Commissioner, Caleb Chichester, discussed radios with Council. Chichester requested \$63,880.83 as an additional appropriation from the General fund for the purchases of the radios. An additional appropriation hearing will be held at the next meeting.

Pursley approved payment application #11 to Cornerstone Stewards in the amount of \$59,541.15, Sweeney seconded. Passed 5-0

Martin provided Council an update for the demolition of the 103 N. Jefferson building. The project was awarded to Kreager Group for \$54,229. The asbestos test came back with less than 2% and Kreager Group has started on the demolition from west to east.

Adrian Halverstadt, Town's attorney, announced there was an executive session held before the Council's regular meeting to address an issue with a customer's utility bill. Upon unanimous consensus, Council determined to have Halverstadt send the utility customer a letter and then go from there based on the customer's response.

Chad Kline, Wells County Economic Development Director, presented the 2020 Economic Development Annual Report.

Upon Council's unanimous consent to consider Ordinance 21-3-1 for adoption on the same day of its introduction, Pursley motioned to approve Ordinance 21-3-1, to implement rates and charges for use of the Archbold Wilson Event Center. Kemper seconded. Passed 5-0

Upon Council's unanimous consent to consider Ordinance 21-3-2 for adoption on the same day of its introduction, Pursley motioned to approve Ordinance 21-3-2, amending the current rates and charges for criminal history checks, fingerprints, and police reports. Kemper seconded. Passed 5-0

Upon Council's unanimous consent to consider Ordinance 21-3-3 for adoption on the same day of its introduction, Pursley motioned to approve Ordinance 21-3-3, for additional appropriations for the General Fund, Police Court Cost Fund, and LIT Public Safety for the 2021 budget year. Kemper seconded. Passed 5-0

Upon Council's unanimous consent to consider Ordinance 21-3-4 for adoption on the same day of its introduction, Pursley motioned to approve Ordinance 21-3-4, establishing two cash change funds and one petty cash fund. Kemper seconded. Passed 5-0

Martin introduced Proposal EST2111 from Cornerstone Stewards for a mechanical bar screen chain replacement at the Wastewater Plant for \$25,874.40. This should last 5-10 years until replacement of the whole entire unit can be completed.

Allison explained she made a few revisions to the Town's Internal Control Policy, mainly concerning the petty cash fund, change fund, and police fees. Kemper motioned to accept the revisions; House seconded. Passed 5-0

Martin explained we are out of contract with Comcast, and they would like to put us back under contract. Martin would like to switch to VoIP phone lines with Adams Wells and still use Comcast internet for an annual cost of \$5,119.08. With this option, there's a one-time expense of 14 phones for \$4,580.95 including installation, phones and fax station. There's also a one-time fee of \$99 for a number transfer fee. Council wanted to check into IFN and see if their network reaches to Town Hall, otherwise Barkley motioned to approve the purchase of phones and lines as presented, Sweeney seconded. Passed 5-0

Chichester, as a resident of West LaFever Street, requested a 3-way stop at the intersection of LaFever Street and Church Street. This also brought up the discuss of speeding on LaFever, Mill and David Road.

Sweeney motioned to approve a utility adjustment of \$760.38 for account 10289644, Kemper seconded. Passed 5-0

Bid openings for Industrial Park Roadway Project is March 18th at noon at Colliers.

Sweeney moved to approve time as presented. Pursley seconded. Passed 5-0
