Barkley opened the Public Hearing for additional appropriations for the 2021 budget. There being no comment or questions from the public, Pursley motioned to close the public hearing, Lewis seconded. Passed 5-0

House moved to approve the minutes of the May meeting. Kemper seconded. Passed 5-0

Barkley motioned to accept the resignation of Joe Lewis from the Park Board, Lewis seconded. Passed 5-0

Pursley motioned to replace the current OPD server up to \$5,900 paid from the Public Safety Fund, payable to Stylus Technologies; Kemper seconded. Passed 5-0

Rigney wants to increase coverage on Mill and LaFever Street and table the conversation of stop signs for a couple of months.

Pursley approved payment application #14 to Cornerstone Stewards in the amount of \$17,163.49, House seconded. Passed 5-0

Pursley motioned to approve CF-1s for Rethceif, Linder Oil, TI Automotive, Perma Column & H&N Properties, House seconded. Passed 5-0

Pursley motioned to approve Resolution 21-6-2 giving TI Automotive a personal property tax abatement for 5 years, being 100% exempt the first four years, and 15% exempt on the fifth year; Lewis seconded. Passed 5-0

Kemper motioned to have Barkley sign an option agreement including the 103 N. Jefferson property; Pursley seconded. Passed 5-0

Barkley approved Ossian Days road closure permit, House seconded. Passed 5-0

Phil DiNovo and Larry Heckber asked Council about shooting off fireworks on Archbold-Wilson's hill on July 3rd. There was much discussion about the possible event. Pursley motioned for Barkley to look over the insurance that would be required for the event; House seconded. Passed 5-0

Kemper motioned to set the minimum bid for the 2011 Dodge Charger at \$4,000, Lewis seconded. Bids are due Monday July 12th.

Barkley motioned to approve taking Cindy Imel off probation and a \$0.50 raise to \$16.50 per hour; Kemper seconded. Passed 5-0

House motioned to approve Resolution 21-5-1 adopting a fiscal plan for the annexation; Lewis seconded. Passed 5-0

Barkley read the synopsis and introduced Ordinance 21-5-2.

Larry Heckber is working to annex The Bridges.

House moved to approve time as presented. Kemper seconded. Passed 5-0

Pursley moved to approve claims of \$478,833.03 as presented. Lewis seconded. Passed 5-0

Pursley moved to adjourn. Kemper seconded. Meeting was adjourned at 8:11p.m.
