**Police Commission:** Caleb presented Chief Rigney and Officer Munsey with accommodations for their assistance in helping medical personal with a non-responsive person on 4/28/22. Caleb told council officer Patrick Piper is no longer working as a part-time officer in Ossian.

**Fire:** Ben F. requested to spend \$4365.75 in order to upgrade their software from Firehouse to ESO since Firehouse is getting shut down at the end of the year; \$1700 for a zymedic rescue tool and \$1254.65 for lettering for the new fire truck from Premier Signs. House motioned to approve the expenses. Ealing seconded. Passed 3-0. House met with fire on the contract, names just need updated and then it is ready to sign.

### **Old Business**

Chad Kline talked about an RFP for the downtown buildings has been created and will hopefully be sent out by the end of the month. We are also looking into what it would take to create a Downtown TIF. Wells County is working on a Strategic Plan, Kline presented a copy of details of the plan for council to look over. He also submitted a proposal from Abonmarche to develop a Community Master Plan for Wells Co. Ossian's share would be between no more than \$25,000. Smaller communities will be asked to pay \$5 - \$8,000. Timeline would be 24 weeks. Barkley asked it be placed on June's agenda so council has time to look it over.

Economic Development Regional Chamber of NE Indiana Strategic Development Plan donation of \$5,000 to be paid out of CEDIT monies approve by Ealing and seconded by House. Passed 3-0

Larry Heckber presented 3 quotes for installing siding on the downtown buildings on the north and south of the building Ossian demoed. Heckber his concerns about loose bricks and debris coming off the building. Revitalization would like to look into extending Lafever out into the park and over to the Braeburn entrance at some point in time.
