Council President, Josh Barkley called the Ossian Town Council Meeting to order with Council members, Dennis Ealing and Jason House Jeff Kemper and Brad Pursley were present.

House moved to approve minutes from May meeting. Pursley seconded. Passed 5-0

# **Dept./Committee Reports**

Fire Dept.: House reported that since the fire department voted him on as a fire fighter then that will mean council person Dennis Ealing will need to replace him as the Fire Liaison.

Park Board: no report

Police Commission: Caleb requested to send Officer Mounsey to Gracie Survival Tactic training in PA. Total cost is estimated \$2500. This would include training \$1200, hotel \$1000 and food. Mounset will drive his own vehicle and not charge mileage to the town. House motioned to approve training. Pursley seconded. Passed 5-0.

Caleb requested council come up with a range in pay for the new police chief. The board has discussed hourly vs salary. The board would like salary and have contacted Attorney Mike Hartburg to see what needs to be done for that. A new job description is being developed and it will be submitted to council for approval soon.

## **Old Business**

Chad Kline Community Master Plan for Ossian and Wells Co. Total cost is \$90,000 with Ossian paying not to exceed \$25,000, Bluffton paying \$35-40,000 and the 3 other smaller communities paying \$5-10,000. Kemper motioned to approve the not to exceed \$25,000. Ealing seconded. Passed 5-0

API pay app#1 (various streets project) Pursely motioned to approved API's Various Streets pay app#1. Kemper seconded. Passed 5-0

Michael & Emily Diss discussion on Ordinance 94.02 'Keeping and Harboring Animals'. They have chickens and found out the town ordinance does not allow them. They are requesting council allow chickens. Until they actually got out of the yard, no one ever complained about the chickens. Council wants time to get more input and it will be put on July's agenda.

Martin presented an Agreement for Improvements in a ROW for Mike Sponseller' property on Bittersweet. Sponseller is wanting to replace existing fence that is in the town's drainage easement. Pursley motioned to approve agreement. Kemper seconded. Passed 5-0

Fireworks permit (Ossian Rehab) Pursley motioned to approve permit. Ealing seconded. Passed 5-0

In December of 2021 after the clerk-treasurer resigned, council agreed to have Council President, Josh Barkley fill in as acting clerk-treasurer. They also gave him permission to sign all necessary documents and checks for the town and gave Vice President Brad Pursley permission to be the alternate to sign checks if Barkley was not able to. Kemper motioned to make this retroactive to Dec. 2021. House seconded. Passed 5-0
