1. Read minutes from park board meeting on March 4, 2013. Jason motioned to approve and Steve seconded. Passed 3-0.

2. Frauhiger Excavating is working on the drainage in the Archbold-Wilson Park. Ossian town employees are installing a 12" tile from inside of walking trail on the north side heading west toward the t-ball

diamonds. The pond has yet to be started.

3. Barry Gordon here questioning a possible 5k run to be held on May 18, 2013. Another date may be considered if a conflict arises. Barry to contact PSI Iota Association and Ossian Revitalization for further interest.

4. Jason motioned to adjourn at 7:55 pm and Max seconded. Passed 4-0.

1. Read minutes from park board meeting on April 1, 2013. Jason motioned to approve and Max seconded. Passed 4-0.
 2. Mulch for all parks has been ordered from Arcadian Farms for a cost of \$ 1380.00. Mulch will be delivered when weather is fit to spread on the ground.
 3. Pena Mechanical is interested in fabricating some equipment for the skate park. Money from \$5000.00 grant is available to be used for skate park equipment.
 4. A new water fountain will be installed on the front of the concession stand for diamond 1.
 5. The next meeting will be held on June 3, 2013
 6. Meeting adjourned at 7:58 pm.

John Roembke of Roembke Mfg. presented three (3) CF-1 forms for approval. He stated that business has picked up in the last six (6) months. Hughes-Lazzell moved to approve the Compliance Forms. Neuenschwander seconded. Passed 3-0

Fire Chief, Ben Fenstermaker, said they have had forty seven (47) runs this year including fifteen (15) structure fires. He said mutual aid is very important. None of the area fire departments, including Ossian, charge for this service. Fenstermaker also stated that there are currently seven (7) positions open with the fire dept. Applications will be accepted until the end of May. He hopes to fill three (3) of them.

Police Chief, Dave Rigney, gave his monthly report. He also reported that he is looking at purchasing a new squad car in the fall. Rigney said that some of the fees charged by his dept. were not being put into the Police Training Fund. Clerk-Treasurer, Jeannette Dickey said the necessary adjustment will be made.

Town Manager, Luann Martin reported the easement from Ossian Furniture will not be needed because they did not need to dig into the store's driveway, as was originally thought, when the sewage line for the new Dollar General was installed. Council agreed to cancel the easement.

Martin reported that the new welcome signs were waiting on an easement which had to be mailed out to be signed. Everything else is ready to go.

Neuenschwander said he hoped to receive the EMS agreement tomorrow, proof read it and get it signed as soon as possible.

Council approved hiring Brian Gear as the seasonal mower for this summer at \$8.00 per hour. Neuenschwander moved and Hughes-Lazzell seconded. Passed 3-0

Martin reported that Fedewa had finished the painting of the water tower, but the paint still didn't match. She will discuss this with Randy Kriscunas of Fleis & Vandenbrink as soon as he is available.

Neuenschwander moved to approve time cards. Hughes-Lazzell seconded. Passed 3-0

Neuenschwander moved to approve claims of \$78,138.21. Hughes-Lazzell seconded. Passed 3-0

Hughes-Lazzell moved to adjourn. Neuenschwander seconded. Meeting was adjourned at 7:30 p.m.
