ORDINANCE 18-4-3

<u>Synopsis</u>: This ordinance, if adopted, will amend portions of Section 53.01 of the Code of Ordinances of the Town of Ossian, Indiana and provide for a six-phase increase in wastewater rates and charges.

AN ORDINANCE AMENDING SECTION 53.01 OF THE CODE OF ORDINANCES OF THE TOWN OF OSSIAN, INDIANA

WHEREAS, the Town Council ("Council") of the Town of Ossian, Indiana ("Town") has enacted and established certain user rates and charges to be collected from the customers of its wastewater works; and

WHEREAS, the Town has obtained engineering evaluations of the Town's responsibility to meet federal and state wastewater standards and obligations and has also obtained financial studies of its wastewater works made by the Town's financial consultant; and

WHEREAS, those evaluations and studies establish that significant and increasing expenditures are necessary to meet the immediate and near-term requirements of the wastewater works and the revenues generated by the rates and charges currently in force are inadequate to meet those requirements; and

WHEREAS, the statutes of Indiana require that the rates and charges to be collected for the use of services rendered by that wastewater system shall be fixed by ordinance adopted in accordance with the requirements of applicable authority; and

WHEREAS, Council has conducted a public hearing regarding this ordinance following notice and publication as required by Indiana law; and

WHEREAS, Council, having evaluated available data regarding these matters, now finds:

- That the existing rates and charges for the use of, and services rendered by, the Town's wastewater works system are insufficient to properly operate and maintain those wastewater works, and to properly serve and safeguard the health, well-being, and property of the Town and its inhabitants and wastewater system users, provide for depreciation, service outstanding indebtedness, and finance necessary upgrades and improvements to the system, and that therefore certain rates and charges should be increased; and
- That biannual adjustments in the wastewater rates would be a prudent and necessary step to ensure that wastewater rates remain sufficient to operate and maintain the Town's wastewater works; and

ORDINANCE 18-4-3

NOW, THEREFORE, BE IT ORDAINED, that Sections 53.01(A)(2); 53.01(A)(3); and 53.01(A)(4) are hereby repealed and replaced in their entirety as follows:

- "(2) The rates and charges below in Sections 53.01(A)(3); 53.01(A)(4); 53.01(B)(2); 53.01(B)(3); and 53.01(B)(8)(a) shall apply for usage and each shall be effective and phased in as follows:
- Phase 1 rates shall supersede and replace current rates and be effective for the first monthly billing period commencing following the adoption of this ordinance.
- Phase 2 rates shall supersede and replace those Phase 1 rates effective as of and for and after the first monthly billing period commencing following May 31, 2019.
- Phase 3 rates shall supersede and replace those Phase 2 rates effective as of and for and after the first monthly billing period commencing following May 31, 2021.
- Phase 4 rates shall supersede and replace those Phase 3 rates effective as of and for and after the first monthly billing period commencing following May 31, 2023.
- Phase 5 rates shall supersede and replace those Phase 4 rates effective as of and for and after the first monthly billing period commencing following May 31, 2025.
- Phase 6 rates shall supersede and replace those Phase 5 rates effective as of and for and after the first monthly billing period commencing following May 31, 2027.
- (3) The water usage schedule on which the amount of the wastewater rates and charges shall be determined shall be as follows:

NOW, THEREFORE, BE IT FURTHER ORDAINED, that Sections 53.01(B)(2) and 53.01(B)(3) are hereby replaced in their entirety as follows:

" (2) Unmetered mobile home parks or apartments will be charged the rate below per month per unit or space available.

NOW, THEREFORE, BE IT FURTHER ORDAINED, that Section 53.01(B)(8)(a) is hereby replaced in its entirety as follows:

" (8)(a) In the event 2 or more dwelling units such as mobile homes, apartments or housekeeping rooms discharging wastewater, water or other liquids into the Town's wastewater system, either directly or indirectly, are users of water and the quantity of water is measured by a single water meter, then in that case billing shall be for a single service in the manner set out elsewhere herein, except that a minimum wastewater additional charge shall be added thereto in the monthly amount set out below for each dwelling unit over 1 served through the single water meter.

BE IT FINALLY ORDAINED, that this ordinance shall be in full force and effect for the first billing period commencing after its adoption, and for all billing periods thereafter as set out herein, all in accordance with applicable law and pending further action by this Council and all ordinances or parts of ordinances in conflict herewith are hereby repealed.
